TUG HILL COMMISSION:

Due to a conflict in my schedule, I may not be able to make it to tonight's Constantia Town Board meeting, so here's a report. As always, let me know if you have any questions or any issues that I can help you with.

First, I'd like to thank Rip Colesante and Chuck Gilkey for attending the Tug Hill Commission meeting in Cleveland this morning. The next Commission meeting in Oswego county is scheduled for this September in Amboy. I'll mention it again as we get closer to September.

The Tug Hill Commission's annual Local Government Conference is scheduled for Thursday, March 26 at Jefferson Community College in Watertown. Conference schedule and registration form was mailed out at the end of 2014. If anyone needs an extra copy, please let me know.

Supervisor Gilkey and I attended the Central New York Regional Economic Development Council meeting in Syracuse last Wednesday.

The next meeting of the North Shore Council of Governments (NorCOG) is scheduled for Thursday, January 29 at the Cleveland Village Hall. Meeting time is tentatively 7:30 p.m. One of the topics on the meeting agenda will be to continue discussion on how best to advance recreation and waterfront access opportunities on the North Shore. NorCOG meetings are open to the public, and you are all most welcome to attend.

Finally, it came to my attention this last week that there is a new step in the town budget process, and that involves a recertification that the town budget that was adopted was actually in compliance with the tax levy limit. Part of this process involves the town board authorizing the town supervisor or budget officer by resolution to certify the town's compliance. I have developed a sample resolution and provided a copy to the town supervisor. I hope that the town will find this useful.

-Mr. Moran asked about the upcoming meeting of NorCOG and what was said at the last meeting as it pertains to access to Oneida Lake on Mill Street. Mr. Moran would like to see some kind of orderly parking in this area. With the number of ice fishermen that come here and access the lake it is really crowded in this area. Mr. Colesante responded that truly they never spoke of lake access as it pertains to ice fishing. Mr. Colesante would like Mr. Gilkey to send a letter to DEC in Cortland, the Natural Resource Supervisor to see if they have any grants or money that they could put towards this area.

-Property Tax Rebate Resolution:
